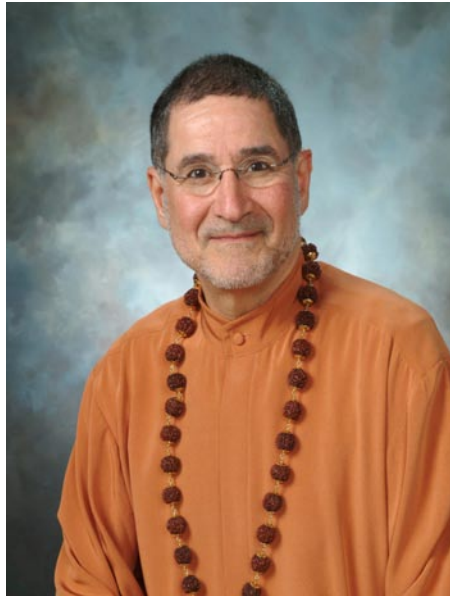

2. Annual Investment Associates
